# **Baskins** Establish **Technology** Center

ngineering, computer, and physics students will benefit from a transformed, state-of-the-art facility thanks in part to an \$894,495 gift by the Peggy and Jack Baskin Foundation, which has supported numerous Cabrillo programs over the years.

The Baskin gift together with a \$3.4 million U.S. Department of Education Hispanic Serving Institution Title III Science, Technology, Engineering, and Mathematics grant, will modernize the 800 Building. Students will have a two-story, 26,700 square foot engineering, physics, and computer science center created for academic support in math and science.

"It will be a great step in getting students involved in engineering," said Jack Baskin, a retired aeronautical engineer and developer. "Engineering is a career with strong job prospects even in a difficult economy."

# \$1 Million Samper Donation Supports the Next **College-Bound Generation**

azmin Torres was among 3,200 excited fourth graders wearing "Future College Graduate" t-shirts and touring Cabrillo College this spring as part of an unprecedented regional educational collaborative to support early college readiness. The youthful college campus day, which introduced prospective students to cook-

ing, accounting, rocket-making, and archaeology, was named the Samper Fourth Grade Experience in honor of Barbara Samper, whose foundation provided \$1 million this year to the Cabrillo College Foundation.

he Cabrillo College Foundation, which celebrates 50 years this year, has raised \$50 million since its inception in 1962. The college has been the recipient of generous support from a community that values quality education.

"As president of the Foundation Board of Directors and a member of the Cabrillo Board of Trustees, I get to meet numerous students who have benefited from the Foundation," said Ed Banks, president of the Cabrillo College Foundation. "We see people who might not have otherwise been able to enter into a particular course of study without assistance. They tell us about the successes they've had and the opportunities it's presented."

This year boasted stunning success. Donors and volunteers helped make possible the first ever countywide Samper Fourth Grade Experience, an effort to kindle the dream of college in prospective students. Ongoing donations supported successful Cabrillo Advancement Program efforts to identify and mentor disadvantaged students starting in the sixth grade. A record number of American Dream scholarships were provided this year by the Ow family to local ethnic minority high school graduates attending Cabrillo College, and a record number of vital emergency Women's Eduational Success grants helped students surmount

financial hurdles threatening their educational dreams. Crocker Endowment grants covered the cost of new health and science equipment for faculty. A gift from the Simpkins family launched the new Veterans' Information Center, a safe and supportive landing place for students who are transitioning to civilian life. Heritage Club members committed to a lasting educational legacy in the future, and there was a record level of giving among President's Circle members.

Among 163 participating community colleges in a nationwide survey, the Cabrillo College Foundation ranked ninth in fundraising and, in California, only one other community college raised more than Cabrillo last year. "I am extremely proud of our foundation for its statewide leadership in fundraising. It says so much about our community's support of Cabrillo," said Brian King, Cabrillo College President.

# Solari Green Technology **Center Opens For Construction Courses**

New State-of-the-Art Facility Is the County's First Platinum LEED Standard Building

he Solari Green Technology Center has received LEED Platinum certification, the industry's highest rating for energy and environmental design.

Martin Johnson, 48, a Construction Management student who has been in the building industry for more than 20 years said, "It is a rapidly evolving industry and contractors need to stay up with the latest technologies and environmental practices."

The 14,000 square foot center, on the Watsonville Cabrillo College cam-

pus, includes a large shop, a lab, storage, offices, and classrooms. It's designed as a teaching structure that displays various building systems and elements contributing to green construction.

"Our classes

mirror the building," said Chuck Mornard, Construction and Energy Management chair. Pointing out glazing on the building's south side and the shading thermal mass, he noted that even the colors and the soundproofing are elements of green design.

The \$11 million project, a brainchild of Tony Campos, was funded primarily by Cabrillo College Measure D bond funds, and Economic Development Administration grants shepherded by Dianne Church. A classroom has been named in honor of

the Les and Jeane Ley family, who donated \$100,000 to help preserve building features essential to the LEED Platinum certification. A \$500,000 gift from Mary Solari and her late husband, Dick Solari, created an endowment for program development and operation costs and the center was named in their honor. Dick Solari started his career as a laborer at Watsonville-based Granite Construction where he eventually served as president, CEO, and chairman of the board. In September, his illustrious career in construction was commemorated and permanently displayed at the grand opening of the facility.

"He'd be very proud of the fact they were able to create and design this mag-





nificent structure and have it meet the standards of LEED Platinum," Mary Solari said. "He was very interested in design architecture. All of this would be exciting to him. It's an honor for the building to carry his name."

This gift created permanent scholarships for recent local high school graduates enrolling at Cabrillo College as part of the Santa Cruz County College Commitment (S4C). This year, 120 scholarships of \$500 each were awarded. Known as S4C, the historic countywide partnership includes all K-12 school districts

in Santa Cruz County, CSU Monterey Bay, and Cabrillo College. "I've never known a whole county to look forward like this, making it possible for every student in



me. Can you imagine if every county did this?" Samper said. Samper is the largest

individual donor to Cabrillo College. In 2007, a gift of more than \$1 million helped the Cabrillo Advancement Program

(CAP), providing second-year \$1,000 San Jose State University, UC Santa Cruz, scholarships to CAP students at Cabrillo.

"Barbara's delight in helping young people dream bigger dreams is creating new futures for many students who might not otherwise consider college," said Brian King, Cabrillo College president.

In addition to supporting student scholarships, Samper's latest gift supports the Visual and Performing Arts division and ongoing maintenance of the music recital hall. In her honor, the state-of-the-art performance facility was named the Barbara Samper Recital Hall.

### Inspired to Inspire: CAP **Graduate Comes Full Circle**

ucila Sanchez, 29, a Cabrillo **College Advancement Program** graduate, has come full circle and become a donor. She says that giving back to the community is something she

learned while a **CAP** student.

"CAP made me understand the importance of giving back," said Sanchez, a grants and contracts specialist at a local non-

profit agency. "I had that in mind that when I had enough money, I would start giving."

Sanchez, a UC Berkeley graduate, is one of thousands of Santa Cruz County students who have participated in a comprehensive mentorship and college prep program that reaches out to middleschoolers with a promise of \$2,000 in scholarships to attend Cabrillo College.

"The message was always the same," she said. "College is there. You have support. We can help you."

Like Sanchez, Julia Cruz-Padillo, 31, also remembered the consistent support from the CAP program. Her parents, who attended elementary school

in Mexico, encouraged her to participate.

"They saw CAP as their ally," said Cruz-Padilla, who attended Cabrillo, graduated from CSU Fresno, and is now a third grade teacher in the Pajaro Valley Unified School

District where she grew up. "I now teach some of my classmates' children," she said.

Edgar Pedraza, 18, who arrived at Cabrillo in the fall, is the second in his family to participate in CAP.

"Once I got the CAP acceptance letter from my sixth grade teacher, I felt relieved that someone believed in me," he said.

About 350 students in six middle

schools and seven high schools were involved in the mentor scholarship program this year. About 60 percent of 50 CAP graduates enroll at



Cabrillo College each year, and many others attend four-year colleges and vocational programs. The program, launched in 1991, is possible thanks to numerous generous donors, including the Barbara Samper Foundation, which supports a second year stipend of \$1000 for CAP graduates continuing at Cabrillo.

"When they receive, they give back," said Samper, who has corresponded with some of the young CAP students. "They told me their personal stories. They shared the difficulties they were having. They said, 'I can't believe someone who doesn't even know me would help me go to college."

upport from the Borina Foundation, which celebrates the legacy of a Pajaro Valley farming family, topped \$1.08 million to the Cabrillo Advancement Program this year.

"I have seen the CAP program grow and succeed," said Bill Locke-Paddon, Borina Foundation co-trustee.

The gifts led to the expansion of CAP's unique academic services and scholarships to children and families at Lakeview Middle School in Pajaro Valley, where families report some of the highest poverty rates in the county.

The Borina Foundation was established upon the death of June Schnacke in 2000. Schnacke, the first female district attorney in California and, later, a deputy U.S. attorney in San Francisco, wanted to honor her parents, Nick and Lucy Borina, and her sister, Mary Ann. Lakeview Middle School is less than two miles from the Borina family's ranch home and just across the street from the cemetery where Borina family members were laid to rest.







### WES Emergency Funding Sets **Students Back on Course**



icole Evans, 31, was back on track, completing her general education requirements and getting a certificate in Journalism. She had pieced together her life, which had been disrupted by addiction, and was hoping to transfer to UC Berkeley. Then her financial situation fell apart.

"It was a really difficult couple of months for me," Evans said, recalling this past year when she was working as a clinical assistant in a local alcohol and drug rehabilitation center, raising her daughter, and trying to stay in school. "I was in such need at that time."

Like many students juggling work and family while in school, an immediate financial gift available through the Women's Educational Success (WES) endowment made the difference between staying the course and giving up or postponing her goals. Within days, Evans had enough cash to cover both that month's rent and childcare.

"This changes their lives," said Peggy Downes Baskin, who cofounded the program with Rachael Spencer in 1997. They started the endowment with 100 women, each



contributing \$100. The idea was to quickly respond to student emergencies with cash grants of \$100-\$750 to help them stay on course.

For Evans, the gift was particularly meaningful because it didn't require months to qualify, and it came from women in the community which meant someone had faith in her as a student. It

inspired her to stay in school and to one day give back.

"The money is relatively small, but the impact can be incredible," said Marilyn Calciano, WES committee co-chair. "It's a great way to leverage our giving and be able to really help women."

A record \$35,000 is allocated this year to WES recipients. The permanent endowment has grown to more than \$1 million and has funded more than \$225,000 in grants since its inception. This year, the Baskin Family Foundation provided

\$10,000 to the WES Endowment, and Carolyn Hyatt, Rachel Wedeen, and Tiffany Karwick joined together to pledge \$10,000 to match individual donations.

"When they can apply for the money and get it so quickly, it keeps them in school. It's very inspiring," said Linda Downing, co-chair of the WES committee.

oan and the late Gerald "Jerry" Griffiths, Cabrillo alumni who have been long-time supporters of the college and its scholarship programs, made a \$10,000 gift this year to support the nationally recognized Stroke and Acquired Disability Center, which will support unique services provided to students facing huge new challenges in their lives.

# **Anonymous Donor Launches** Foster Youth Program with \$100K Gift

n anonymous donor funded the creation of a new student men-L torship and support program aimed at increasing the success of foster youth students at Cabrillo. The gift provides scholarships, emergency grants, outreach, administrative and academic support, and peer mentorship to more than 100 students.

"It is a blessing for someone to have a heart like that which makes this possible," said Tamauri Olive, 20, a health sciences student and foster youth student who will be one of four paid mentors to help foster youth on campus. "It's important for students to know there are others who have been in the same situation and we're there for them."

Foster youth "are really at risk if they don't make it academically or economically," said Joseph Watkins, 20, a political science and philosophy student who grew up in the foster care system and is a student mentor.

Only about 3 percent of youth from the foster system attend college, and less than 1 percent actually complete a degree or certificate, according to national research. Lacking financial and emotional support are common reasons for dropping out of college.

With the new Cabrillo program, foster youth students now have a designated meeting space. They are creating an in-





"Cabrillo's Foster Youth program is an opportunity to break the cycle of disadvantaged circumstances that surround foster youth," said Watkins.



### Crocker Endowment Funds Classroom Grants

ith a small electrode banded to her forearm, pre-nursing student Aislinn Gunn, 19, watched her finger twitch on its own accord, experiencing firsthand how electrical current controls muscle contraction.

"Our instructor tells us what happens in lecture, but here you really see how it works," Gunn said. "You can experience it in lab."

The new equipment, which brings instructor Denise Lim's human physiology lecture to life and replaces the use of frogs in classroom experiments, is available to more students this year thanks to a Crocker Endowment grant.

"Any time the students experience for themselves what it feels like and what it's doing to their own bodies, it's much more meaningful," Lim said.

The Crocker Endowment also paid for an intravenous infusion pump to replace obsolete equipment in the Nursing Simulation Laboratory.

"With this upgrade, students will program and administer multiple IV fluids to the mannequin during high-fidelity simulation exactly as it is done in the clinical setting," said Marjorie Miller, Simulation Program coordinator.

The Crocker Endowment Grants are part of a \$1 million donation by Dick and Theresa Crocker, the first Cabrillo alumni to give such a large donation.

"As Cabrillo College alumni, we know Cabrillo College made a difference in our lives. When we hear stories from students

who wouldn't have the financial resources to follow their dreams apply themselves – that probably means more to us than anything," Dick Crocker said.

In addition to the Crocker Endowment Grants, the Faculty Grants for Student Success Endowment and the Engineering and Applied Science Endowment also provide annual support of more than \$55,000 each year to support faculty and enhance student learning.

### Simpkins Gift Supports Veterans' Information Center

en Meade, 29, a second year Cabrillo College astronomy student who is serving as president of the student organization running the newly expanded campus Veterans' Information Center shared, "It's easy to feel isolated, especially when you've been deployed three times like I have." This year, thanks in part to a generous donation by Brigid and Bill Simpkins, veterans have a new home on campus where they are helping each other.

For Sarah Slotnick, 25, a business student who served in Afghanistan before returning to civilian life and enrolling at Cabrillo this year, it's an unexpected link back to the community.

"The feeling is really almost beyond words," she said. "You don't expect it. It

makes you feel like you are part of the community. You are welcome here."

Currently there are over 200 veterans and dependents at Cabrillo, a 100 percent increase since the Center first opened just over a year ago. The Simpkins gave \$22,230, about half of which went toward the purchase of computers and furnishings for the Center. Their gift also supported the Stroke Center, Men's Water Polo, and their endowed scholarship.

Brigid Simpkins, who serves as a member of the Cabrillo College Foundation Board of Directors, said that she and Bill heard of the need from a student veteran.

"It's not an easy thing to return from serving your country and go to college," she said.







### **Total Net Assets and Endowment Growth 1990-2012**






**Total Gifts 1990-2012**

In addition to renovation and maintenance of the building, the gift establishes the Baskin Girls in Engineering and Technology Summer Program, an annual one-week science program for local middle school girls taught by women. The Baskins support a similar program at UC Santa Cruz.

"We love the idea of encouraging young girls to consider pursuing studies in engineering and technology," said Jo-Ann Panzardi, Engineering department chair and instructor. "They will have lots of fun exploring careers through handson projects."

"Catching girls early on and introducing them to science and technology before their interest falls off is critical," said Peggy Downes Baskin, who co-authored a book on successful women executives in Silicon Valley.

Each semester, almost 1,400 Cabrillo students participate in engineering, physics, and computer science transfer programs, and en-

gineering technology, and computer information systems occupational programs. Cabrillo is the only community college in the tri-county area with a complete lower-division engineering program.
